Subject: Clarification on Online Admission Guidelines for Session 2020-21

Madam/Sir,

An email dated 22.07.2020 has been received from Deputy Commissioner, Ahmedabad Region for clarification of following points in Admission Guidelines 2020-21. The clarifications as requested is placed below for information and implementation by all Regional Offices/Kendriya Vidyalayas:

1. The heading - The concessions to be allowed for class XI standard on page 19, the point (B) states that "Students belonging to SC/ST/OBC/Divyang(PH) would be given upgradation in aggregate by 4% marks for the purpose of Admission to class XI."

The Admission Guidelines 2019-20 stated the same point as this. "(B). the Students belonging SC/ST/Divyang (PH) would be given up gradation in aggregate by 4% marks for the purpose of admission to class XI.

Please Clarify whether this concession is applicable to all OBC students **OR** students of "OBC-NCL"

Clarification: This concession is applicable to all OBC students.

2. In para 9 of Part-C "Method of Admission in Class XI" on page 18, it is stated that " The Deputy Commissioner may use her/his discretion in lowering the eligibility criteria to the extent as indicated below" **but the eligibility criteria is not mentioned.** Kindly clarify whether it will be the same as that mentioned in the Admission Guidelines 2019-20.

Clarification: Yes, it will be the same as that mentioned on page No 17 of the Admission Guidelines 2019-20 and reproduced below:

KV Students:

Admission in different streams viz Science, Commerce, Humanities of Class XI in KVs for KV students will be based on Marks scored in class X exams as under:

1. Science Stream: A minimum of 55% Marks in aggregate of all subjects.
2. Commerce: A minimum of 50% Marks in aggregate of all subjects.
3. Humanities Stream: All students of KV if declared successful in class X exam.

Note:- If seats remain vacant in class XI even after admitting the children of KV/ neighboring KVs then the admissions to non - KV children may be granted on the same criteria, in the sequence of categories of priority.

3. In Para 8, Part-C on page 17 of Admission Guidelines in "Method of admission of Class IX" it is stated that "An Admission Test shall be conducted and a merit list will be prepared for each category of priority separately, Admission shall be granted in the sequence of priority categories in order of merit."


Please clarify whether the Admission Test will be conducted in the Pandemic COVID-19 situation or can admission be granted on the basis of priority categories in this academic session 2020-21.

Clarification: Fresh admissions to Class-IX (if vacancy exists) are to be granted on the basis of Priority Categories in this academic session 2020-21 by following the existing method of Fresh Admission for Class II to VIII i.e. without conducting admission test.

In addition to above mentioned points, the Competent Authority has extended the date of declaration of select list for Class-II onwards up to 31.07.2020 keeping in view the Online verification of documents. A thorough check of requisite documents for admission is required before granting admission by following the protocol of COVID-19, already circulated.

This issues with the approval of Commissioner, KVS.
